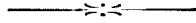

OBJECTS OF THE SCHOOL.



The School is conducted as a Public Secondary Day School for Boys and Girls, under the regulations of the Board of Education.

The temporary Schools for Boys and Girls held respectively at Broomfield Park and Avondale Hall have been amalgamated and the pupils transferred to the new School.

No pupil under 11 years of age, or over 15 years of age, will be admitted to the School, nor shall any pupil remain in the School after reaching 18 years of age, except on the recommendation of the Head Master and with the sanction of the Governors.

Entries may be received for pupils who will become 11 years of age during the term of admission.



The Course of Instruction includes :—

Scripture, Reading, Writing, Geography and History, English Grammar, Composition and Literature, French, German, Latin, Arithmetic, Mathematics, Science (Chemistry, Physics and Botany), Drawing, Manual Instruction, Drill, Class Singing, Needlework, Cookery, with such other subjects as the Governors may arrange from time to time.

The School will be inspected and examined by the University of London, and by the Board of Education.

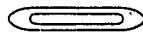
BUILDINGS.

The School Buildings are situated in Fox Lane, Palmers Green, close to the Palmers Green Railway Station. Electric trains also run past the end of the road.

The School buildings consist of:—

A Large Central Hall, 14 Classrooms (accommodating 336 scholars), Chemical and Physical Laboratories (with Balance and Dark Rooms attached), Large Art Room, Manual Training Room, Domestic Training Room, Staff Rooms, and Cloak and Changing Rooms.

There is a Playing Field of $4\frac{1}{2}$ acres attached to the School.



FEES.

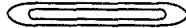
The School Fees, payable in advance, are £2 2s. 6d. each Term, which include a charge for the use of Class Books, for Stationery, and for Games. These Fees are to be paid to the Palmers Green Branch of the London and Provincial Bank. A demand note is sent to each parent at the beginning of the Term.

The Head Master is instructed to refuse admission to all pupils, other than new pupils and holders of scholarships, whose fees have not been paid before the First Monday of each Term, and to all new pupils whose fees are unpaid upon the Second Monday after admission.

These rules will be strictly adhered to.

All ordinary books and stationery are provided by the Governors, but the books remain the property of the School.

Any careless treatment or wilful damage of School property by a pupil must be paid for by the parent or guardian of the pupil.



HOURS. - - TERMS.

The School will not meet on Saturdays.

The Year is divided into three Terms of about thirteen weeks each, with about seven weeks' holiday in the summer, three weeks at Christmas, and three weeks at Easter.

GENERAL.

A Report of the work of each pupil will be forwarded to his or her parent or guardian at the end of every Term.

A Form of Application (obtainable at the School) for the admission of a pupil must be filled up and sent to the Head Master, together with a certificate of good character from the pupil's last school—if any.

All pupils are examined before admission, and are required to reach a certain standard according to age. No pupil is admitted who is unable to pass a simple examination in Reading, Writing from Dictation, Grammar, Elementary Arithmetic, and Geography.

No pupil is allowed to attend School from a house in which there is a case of infectious illness; and if the pupil has suffered from any infectious disease, a Doctor's Certificate is required before resuming attendance at School.

The Governors require one month's notice of the withdrawal of a pupil, to expire at the end of a Term. This notice must be sent in writing to the Head Master. In the alternative half a Term's fees must be paid.

It is earnestly requested that parents should see that proper attention is given to the preparation of home lessons. Without due preparation the value of the work attempted at School is greatly lessened.

No cause except illness is considered a sufficient excuse for absence or neglect of home work, unless permission has been obtained previously from the Head Master. Pupils returning from School after absence must bring a note from their parent or guardian, explaining the cause of absence.

Every girl must wear the School Hat and every boy the School Cap to and from School.

Provision is made for the following Games :--Football, Hockey, Cricket, Lawn Tennis, and Net Ball.

The Governors are not liable for any property which may be lost from the School Buildings.
